# Participation conditions Credit Expo Netherlands 2025

The provisions under which participation in 'Credit Expo Netherlands 2025' (hereinafter: the event) can take place are set out in the following terms and conditions of participation.

#### Organisation

Credit Expo 2025 is organised by: Next Level Academy BV (hereinafter referred to as: 'the organisation').

#### **Venue and Date**

The event will take place at 1931 Congress Center, Oude Engelenseweg 1, 5222 AA 's-Hertogenbosch, The Netherlands, on Thursday, 6 November 2025.

#### **Opening Hours**

Opening hours for visitors: Thursday, 6 November 2025, from 9:00 AM to 6:00 PM. Opening hours for partners: Thursday, 6 November 2025, from 7:00 AM to 7:00 PM.

#### **Standard stand construction**

The organisation offers standard stand construction in sizes of 6 m², 9 m² or 18 m². The standard stand construction includes partitions of 250 cm high, company name and stand number display, a lockable counter, a standing table with stools, lighting and a power outlet including power consumption. The exact specifications of the standard stand construction will be announced in the trade fair manual no later than the last week of September. The standard stand construction can be adapted in consultation with the organisation. Partners can also arrange their own stand construction in consultation with the organisation. Any additional costs will be borne by the partner.

#### **Construction and dismantling**

Partners using their own stand construction can build their stand on Wednesday, 5 November 2025 between 11:00 AM and 6:00 PM. Partners using standard stand construction can build their stand on Wednesday, 5 November between 3:00 PM and 6:00 PM or on Thursday, 6 November between 7:00 AM and 9:00 AM. Dismantling of your own stand construction has to take place on Thursday, 6 November between 6:00 PM and 8:00 PM. Stands with standard stand construction have to be cleared between 6:00 PM and 7:00 PM.

#### **Partners**

The organisations participating in the event are economically active in the Dutch market for credit management or related services. This is at the discretion of the organisation. The organisation reserves the right to refuse partners.

#### **Programme**

Only products and services aligned with the event's aim - to provide the broadest possible overview of the credit management market - may be presented. This is at the organisation's discretion.

#### **Access policy**

Credit Expo is open free of charge to professionals involved in credit and cash management solutions for their own organisations as policy-makers, buyers or end-users. Individuals working for or on behalf of a supplier, intermediary or consulting firm are not part of the visitor target group and are not entitled to free entry. Each partner will receive an unlimited number of registration codes to distribute at their discretion to prospects and/or relations belonging to the target group. The organisation reserves the right to refuse registrations if it appears that the access policy is not properly observed.

#### **Special activities**

Special activities on stands, such as presentations or performances involving audio-visual elements, require prior permission from the organisation. Permission must be requested no later than 30 days before the event. Activities must not obstruct aisles or cause noise pollution. The organisation reserves the right to impose additional restrictions to ensure an optimal experience for all participants.

#### **Reservations due to changes**

The organisation reserves the right to change the event's date, time, or location due to special circumstances or organisational reasons. Compensation cannot be claimed in such cases.

#### **Cancellation conditions**

Due to the one-off nature of the event, cancellation or rescheduling by partners is not possible.

#### **Payment terms**
